Re: Order to Cease and Desist the Solicitation and Sale of Service Contracts in Nevada
Cause No. 17.0503

To Whom It May Concern:

Auto Assure, LLC ("Auto Assure") has solicited the sale of service contracts in the State of Nevada through the use of the United States Postal Service and the internet. It is unlawful for an entity to sell or offer for sale service contracts in Nevada without first being registered with the Nevada Division of Insurance. NRS 690C.150. If Auto Assure wishes to do business in Nevada it must submit an application for registration within 45 days of the date of this letter. In the meantime, Auto Assure must immediately cease soliciting and selling service contracts in Nevada pursuant to the enclosed Cease and Desist Order issued by the Nevada Commissioner of Insurance.

Auto Assure's application for registration is not a substitute for the other requirements listed in the enclosed order. Auto Assure must still submit a complete list, including names and contact information, of those Nevadans who have purchased a service contract, and provide an immediate disclaimer on its website, social media accounts and other marketing materials, announcing that Auto Assure's service contracts are not available in Nevada.

Please note that compliance with the directives in this letter and the Order to Cease and Desist do not guarantee that Auto Assure will receive a certificate of registration after applying for the same. Additionally, having solicited and sold service contracts in Nevada without proper registration will subject Auto Assure to administrative penalties and fines.

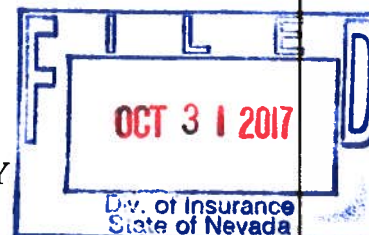

9 The State of Nevada, Department of Business and Industry, Division of Insurance

15 It is unlawful for corporations and/or persons to provide, issue, sell, or offer for sale,
16 service contracts within the State of Nevada without first obtaining a proper certificate of
17 registration from the Division pursuant to Chapter 690C of the Nevada Revised Statutes
18 (“NRS”). NRS 690C.150. The Commissioner of Insurance (“Commissioner”) has exclusive
19 jurisdiction to regulate, enforce or effect full compliance with regard to the insurance code of
20 the State of Nevada, including NRS Chapter 690C. NRS 679B.120 and NRS 679B.130.

21 The Division has received and verified, credible information that AUTO ASSURE, LLC
22 (“AUTO ASSURE”) has provided, issued, sold, or offered for sale, service contracts within the
23 State of Nevada through the use of the United States Postal Service and the website
24 autoassure.com without first obtaining a proper certificate of registration pursuant to NRS
25 690C.150. *See* Exhibits A and B.

26 WHEREAS, AUTO ASSURE’s conduct is injurious to the rights and interests of the
27 public or policyholders in Nevada, and emergency action is imperatively required.

28 WHEREAS, AUTO ASSURE may request a hearing regarding the instant Order in
accordance with the provisions of NRS 679B.310.

1 NOW, THEREFORE, PURSUANT TO NRS 679B.120 and 679B.140, AUTO ASSURE
2 IS HEREBY ORDERED TO IMMEDIATELY CEASE AND DESIST FROM PROVIDING,
3 ISSUING, SELLING, OR OFFERING FOR SALE, SERVICE CONTRACTS WITHIN THE
4 STATE OF NEVADA.

5 IT IS FURTHER HEREBY ORDERED THAT AUTO ASSURE SHALL, within fifteen
6 (15) days of receipt of this order, furnish to the Division a complete listing, including contact
7 information, of all Nevada residents who have purchased any service contract, insurance or
8 insurance-related product from AUTO ASSURE.

9 IT IS FURTHER HEREBY ORDERED THAT AUTO ASSURE SHALL
10 ADMINISTER the service contracts existing in the State of Nevada and pay all legitimate
11 claims now owing, and shall work with the Division to resolve any existing or future consumer
12 complaints.

13 IT IS FURTHER HEREBY ORDERED THAT AUTO ASSURE SHALL immediately
14 provide a disclaimer and/or disclosure on its internet website, marketing materials, written
15 communications and through oral communication, indicating that its service contracts and any
16 other services are not available to persons or entities in the State of Nevada.

17 FURTHER, AUTO ASSURE IS HEREBY NOTIFIED that the Commissioner may,
18 after notice and opportunity to be heard, impose all of the following administrative fines:

- 19 • NRS 690C.120(1)(b), NRS 679B.185(1), fines of \$10,000 for each act or
20 violation;
- 21 • NRS 690C.330, fines of \$10,000 for similar violations;
- 22 • NRS 690C.120(1)(f), NRS 686A.030, NRS 686A.183(1)(a), fines of \$5,000 per
23 violation;
- 24 • NRS 690C.120(1)(f), NRS 686A.040, NRS 686A.183(1)(a), fines of \$5,000 per
25 violation.

26 FURTHER, AUTO ASSURE IS HEREBY NOTIFIED that if AUTO ASSURE has
27 information that will alter this Cease and Desist Order, or if it has any questions regarding this
