ORDER TO CEASE AND DESIST

The State of Nevada, Department of Business and Industry, Division of Insurance ("Division"), sends greetings to:

It is unlawful for corporations and/or persons to provide, issue, sell, or offer for sale, travel insurance within the state of Nevada without first obtaining proper licensure from the Division pursuant to Chapter 680A of the Nevada Revised Statutes ("NRS"). The Commissioner of Insurance ("Commissioner") has exclusive jurisdiction to regulate, enforce or effect full compliance with regard to the insurance code of the State of Nevada, including NRS Chapters 679B, 680A and 683A.

The Division has verified that eSurranty, Inc. [sic] ("eSurranty") has provided, issued. sold, or offered for sale, travel insurance within the State of Nevada through the use of the website esurranty.com without first obtaining proper licensure pursuant to NRS 683A.241, NRS 683A.261 and NRS 683A.271. See Exhibit A.

The Division has also verified that the President, Director and Treasurer of eSurranty, Angleo Maimone, has been convicted and served a prison sentence for crimes involving theft and/or fraud, including multiple counts of grand theft and forgery.

WHEREAS, eSurranty's conduct is injurious to the rights and interests of the public or policyholders in Nevada, and emergency action is imperatively required.

WHEREAS, eSurranty may request a hearing regarding the instant Order in accordance with the provisions of NRS 679B.310.

NOW, THEREFORE, PURSUANT TO NRS 679B.120 and 679B.140, ESURRANTY IS HEREBY ORDERED TO IMMEDIATELY CEASE AND DESIST FROM PROVIDING, ISSUING, SELLING, OR OFFERING FOR SALE, TRAVEL INSURANCE WITHIN THE STATE OF NEVADA.

IT IS FURTHER HEREBY ORDERED THAT ESURRANTY SHALL, within fifteen (15) days of receipt of this order, furnish to the Division a complete listing, including contact information, of all Nevada residents who have purchased travel insurance or travel insurance-related product from eSurranty.

IT IS FURTHER HEREBY ORDERED THAT ESURRANTY SHALL, within fifteen (15) days of receipt of this order, furnish to the Division a copy of any and all insurance contracts offered to consumers by eSurranty.

IT IS FURTHER HEREBY ORDERED THAT ESSURANTY SHALL administer the travel insurance policies existing in the State of Nevada and pay all legitimate claims now owing, and shall work with the Division to resolve any existing or future consumer complaints.

IT IS FURTHER HEREBY ORDERED THAT ESURRANTY SHALL immediately provide a disclaimer and/or disclosure on its internet website, marketing materials, written communications and through oral communication, indicating that its travel insurance, and any other services are not available to persons or entities in the State of Nevada.

FURTHER, ESURRANTY IS HEREBY NOTIFIED that the Commissioner may, after notice and opportunity to be heard, impose all of the following administrative fines:

- NRS 679B.185(1), fines of \$10,000 for each act or violation;
- NRS 686A.030, NRS 686A.183(1)(a), fines of \$5,000 per violation;
- NRS 686A.040, NRS 686A.183(1)(a), fines of \$5,000 per violation;
- Fines deemed appropriate for violations of NRS 683A.461.

FURTHER, ESURRANTY IS HEREBY NOTIFIED that if eSurranty has information that will alter this Cease and Desist Order, or if it has any questions regarding this matter, it may contact David Hall, Insurance Counsel, at 1818 East College Parkway, Suite 103, Carson City, Nevada 89706, by U.S. Mail, or by email, dhall@doi.nv.gov.


