We are pleased to submit the information filing for the Sole Proprietor/1099 Employee Association Health Plan that will be offered through the Greater Las Vegas Association of REALTORS® (GLVAR). The GLVAR's Association Health Plan will be called the Greater Las Vegas Association of REALTORS® Health Plan and will be available to GLVAR sole employer members that are members in good standing with the association. This AHP will only be available to individuals that meet the requirements to be Sole proprietors, groups of one, or working owners within the meaning of Department of Labor Regulation Section 2510.3-5(e)

The following items are included in the information filing for the Greater Las Vegas Association of REALTORS® Health Plan.
