#### **1. Call to Order/Roll Call**

The meeting was called to order at 10:02 a.m.  
Jeremey Gladstone proceeded with the roll call and a quorum was established.

#### **2. Introductory Remarks**

Mr. Gladstone with the Division of Insurance (Division) reminded the Council and public of the Council's charge which establishes the scope of the council's work and determines recommendations to the Commissioner as to what network adequacy requirements should be; monitoring and enforcement do not fall within the council's control. Regulations are available per Nevada Administrative Code under chapter 687B3750.

He also reminded participants that Nevada Open meeting law does apply which means that everything the council does must be done openly, must be available to the public and must be

properly noticed and recorded. Meetings are recorded and available to the public; and participants were asked to identify themselves for the recording prior to speaking.

### **3. Public Comment**

There is no public comment.

### **4. Approval of the Minutes from the July 21, 2022, Meeting**

Howard Baron made a motion to approve meeting minutes; seconded by Sarah Fox. None were opposed, motion carried unanimously.

### **5. Discussion, Deliberation, and Potential Direction by Council Regarding Network Adequacy Standards for Plan Year 2024.**

Jeremy Gladstone opened agenda item requesting any further discussion for Plan Year 2024. No discussion from the Council was had, Jack Kim recommended moving onto Agenda item #6 with agreement from the rest of the Council.

### **6. Review, revise, and approve final Report Plan Year 2024 recommendations. (For Possible action)**

Jeremy Gladstone explained the updates made to the Report since being sent out to the Council after the prior meeting, specifically those edits requested by Jack Kim. The Council was addressed individually for any thoughts concerning the draft. Howard Baron made a motion to approve, seconded by Jack Kim. None were opposed, motion carried unanimously.

### **7. Discussion of future meetings.**

Jeremy Gladstone discussed the next Network Adequacy Advisory Council meeting to potentially be held in March of 2023 and advised that the Division would reach out for possible dates.

- Howard Baron referenced Jack Kim's addition to the PY2024 report and requested information be presented on whether telehealth can be considered in Network Adequacy Standards and agreed it should be on the agenda.
- Jack Kim requested a legislative update on bills that may impact the Council and Network Adequacy.
- Joy Cleveland requested an update on the No Surprise Bill Act and the impact it may have on Network Adequacy from a market view.
- Howard Baron made an additional request for an update pertaining to legislation passed to improve workforce data collection.
- Patrick Kelly noted the Patient Protection Committee is looking at a bill that prohibits corporations from employing physicians which would impact Network Adequacy and requested that the Division report on that topic.
- Mr. Gladstone also indicated that he could get updates on the all payor's claim database and the public option.
