NOTICE OF CANCELLATION OF SCHEDULED HEARING for the Adoption, Amendment or Repeal of Regulations of The Department of Business and Industry, Division of Insurance

The State of Nevada, Department of Business and Industry, Division of Insurance ("Division"), (775) 687-0700, has **CANCELED** the public hearing which was set for **9:30 a.m. on September 29, 2017**. The purpose of the hearing was to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations pertaining to Chapter 679B of the Nevada Administrative Code ("NAC"), concerning:

LCB File No. R026-17. Electronic Transactions For Insurance-Related Notices.

A regulation relating to insurance; setting forth requirements for the verification or acknowledgement of receipt for certain notices that are delivered by electronic means; and providing other matters properly relating thereto.

The reason for cancellation of the hearing is because the Division has withdrawn the proposed regulation.
