Re: Presentation of Proposed Regulations, LCB File No. R185-22 Business of Bail – Supplemental Comment

Dear Commissioner:

I would like to submit a supplemental comment on the proposed regulations.

Section 17, amending NAC 697.130(5) – This section only allows a bail agent to post a bond with a court or a jail. Most bail agents use bail runners to post a bond. Many bail agents use bail runners because they are the only person in the office that is licensed to complete the bail transaction. This would hurt many bail agents because they would have to close their office in order to post a bail bond. And, this would delay posting of bail bonds because a bail agent would have to wait until there was no one in the office that needed to post a bail bond before closing the office. It is common in other industries to use runners to post or file documents. For instance, attorneys are licensed to file a document but may have a runner take the documents to the court to cause the actual filing. The posting of a bond is an administrative task and does not require a licensed bail agent to be present to effectuate the posting. Thus, we recommend that you keep the previous language of this subsection.

Thank you for your consideration of these supplemental written comments to the proposed bail regulations.
